Dear Madame:

This letter is in response to a Federal Election Commission letter dated January 22, 2009. The FEC addressed three items. Responses to these items are listed below.

Item 1. Our October Report contains incorrect Column B figures for Lines 6 (b), 6 (c), 7 (a), 17, 20 (a), 20 (d) and 22 of the Summary and Detailed Summary page information. We were asked to file an amendment showing the figures on an election cycle to date basis. Our October Report (7/1/08-9/30/08) was correct except for Column B Lines 11a (i and ii). The itemized and unitemized individual contributions were off on the Election Cycle to Date column due to a computer software problem. I have filed an amendment to this report with correct itemized and unitemized figures. There was no change in Column A. The Column B figures were all correct except for the Lines mentioned above.

Item 2. We were asked about the itemization of two particular PACs and were asked to amend our report to correct discrepancies in the aggregate total for the entities Amgen Corporation PAC and Major League Baseball PAC. The Reported aggregate amounts were correct. No amendment was filed. Amgen PAC had given \$1500.00 on 10/3/2007 and \$1500.00 on 12/15/2007 which were reported in our Year End 2007 Report (10/1/2007-12/31/2007). That made the aggregate amount \$5,000.00 for the Election Cycle to date once we reported the 7/1/2008 contribution for \$1,000.00 and 9/10/2008 contribution for \$1,000.00 on our October 2008 Quarterly Report (7/1/2008-9/30/2008).

Major League Baseball PAC contributed \$1,000.00 on 10/3/2007 and was reported in our Year End 2007 Report. After their 9/30/2008 contribution for \$4,000.00, the total was \$5,000.00 and correctly reported.

Item 3. We were asked to explain receipts from the Senate Majority Fund from Line 15. We have reoccurring receipts every month from the Senate Majority Fund. We share a rented space and therefore split expenses for the office. The amount \$600.30 is P.O. BOX 10246 • Phoenix, Arizona 85064 • (602) 840-0306 • Fax (602) 840-1970

for the rental of office space. The amount \$117.50 is for Telephone and Internet usage. The amount \$55.00 is for rental of equipment. The payments made by the Senate Majority Fund are based on fair market value of the service provided. The rent of office space is based on square footage used exclusively by each committee and the frequency of use of common areas. Office equipment rental is based on fair market rental of items of equivalent age on the general market; ie: desk, chair, filing cabinets, and computers, copier, and fax machine. Reimbursement for telephone and internet is based on a percentage use by each committee. At this time our usage is split 50/50 between the two committees. After speaking to our analyst Christopher Whyrick he informed me that I did not need to amend our report but to explain the receipts. In future reports there will be a listing in the memo section.
