
Please accept this in lieu of my original 1997 year end report. I tried to address each of the five points in your letter, copy attached.

-The beginning cash balance of this report should equal the ending balance of your 1997 Mid-Year Report. Please clarify this discrepancy and amend any subsequent report(s) that may be affected by this correction.


-Your calculations for Line 11(a)(ii), Column B appear to be incorrect. FEC calculations disclose this amount(s) to be \$11,160. Please provide the corrected total(s) on the Detailed Summary Page.

-Please provide the total(s) for Line 23, Column B of the Detailed Summary Page. Note that changes in your figures may affect your Column B totals on this report and/or on subsequent reports.

-Your report disclosed a category of financial activity that has been reflected on the wrong line of the Detailed Summary Page. Other disbursements (i.e. contributions to non-federal candidates/committees) should be properly disclosed on a separate Schedule B (if applicable), supporting Line 29 of the Detailed Summary Page.
