
Dear Madame:

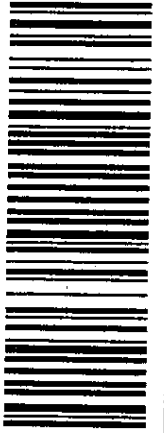
