# OF SORGHUM PAC

# **ARTICLE ONE**

The name of the entity is the Sorghum PAC referenced in this document as the Sorghum PAC.

## **ARTICLE TWO**

The entity is a political action committee under Federal Election laws.

## **ARTICLE THREE**

The period of its duration is perpetual.

## ARTICLE FOUR

The Sorghum PAC was created by the Board of Directors of the National Sorghum Producers Association to advance the interests of sorghum producers. The Sorghum PAC does this by helping to elect and reelect individuals to federal offices such as the Presidency, Senate, and House of Representatives who support sorghum producers and a strong, effective sorghum industry.

The primary objectives of the Sorghum PAC are as follows:

- 1. To further the legislative interests of sorghum producers.
- 2. To accept and receive monetary contributions voluntarily donated by any person desiring to advance the interests of sorghum producers or the U.S. agriculture industry.
- To disburse monetary contributions to the campaign committees of those incumbent Senators and Representatives seeking reelection, or those running for a Senate or Representative seat who have expressed support for the sorghum industry.
- 4. To carry on such other activities as may be deemed practicable relating to legislation and candidates for election or reelection to the U.S. Senate, the U.S. House of Representatives, or the President of the United States in order to further serve the interest of U.S. sorghum producers.

The purposes for which the PAC is organized are exclusively political education, and such related activities as are permitted by a corporation exempt from taxation under Section 527 of the Internal Revenue Code of 1986, as amended. The corporation shall be operated exclusively for those purposes. The PAC shall not engage in any act prohibited to a corporation exempt from taxation under Section 527 of the Internal Revenue Code of 1986, as amended now and hereafter. If at any time this PAC is a private foundation within the meaning of Section 509(a) of the Internal Revenue Code, it shall distribute its income each taxable year in such time and manner as not to become subject to tax under Section 4942 of the Internal Revenue Code, nor shall the corporation engage in any act of self-dealing, retaining excess business holdings, making any investments which would subject the foundation to taxation, or making taxable expenditures (as defined by the Internal Revenue Code).

#### **ARTICLE FIVE**

The PAC shall have a board of directors and designate three officers: the Treasurer, Assistant Treasurer, and Custodian of Records.

- A. Designating a PAC board to consist of no less than three members of the National Sorghum Producers Association or three sorghum producers. The board members are responsible for reviewing solicitations and making recommendations for disbursement.
- B. Designating a Treasurer. This individual is a member of the National Sorghum Producers Association or is a sorghum producer and is responsible for approving all documents submitted to the Federal Election Commission including registration and required reporting documents. The treasurer is responsible for accepting contributions and making expenditures on behalf of the PAC.
- C. Designate an Assistant Treasurer referred to as a Designated Agent. This individual is a member of the National Sorghum Producers Association board and is responsible for fulfilling the responsibilities of the Treasurer if the designee is unable to fulfill the duties.
- D. Designate a Custodian of Records. This person is responsible for maintaining the books and records of the PAC.

#### **ARTICLE SIX**

Upon dissolution of the PAC, its assets shall be disposed of exclusively for the purposes of the PAC or distributed to such organizations organized and operated exclusively for

charitable or educational purposes as shall, at the time, qualify as an exempt organization under Section 501(c)(3) of the Internal Revenue Code. No part of the net earnings of the PAC shall inure to the benefit of or be distributable to any director, employee, or other individual, partnership, estate, trust, or corporation having a personal or private interest in the corporation, except that the PAC shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein.

### **ARTICLE SEVEN**
