Dear Ms. Lewis:

Thank you for the \$500 contribution from the Manufactured Housing Institute Political Action Committee. The date a contribution is made by the contributor and the date the contribution is received by the campaign are significant for purposes of reporting. Since this contribution was postmarked March 31, 2000 and received on April 4, 2000 it does not qualify as a 2000 Primary Election Contribution.


