Amendment in response to RFAI dated August 31, 2022 re JULY QUARTERLY REPORT (04/14/2022 - 06/30/2022). Upon reviewing the RFAI and discussing the RFAI with Reports Analysis Division staff, the Committee examined 18 donor records reflecting electronic donations that were at or near the end of the primary election period and the beginning of the general election period in 2022. The Committee discovered that the identified reporting errors were occasioned by two issues: (1) The identified donations were made electronically through a third-party credit card processing vendor (ActBlue) during the primary season election period and the donors made a single contribution that defaulted to the designation of the general election period with the actual donor intent that the donation be split between the primary and general election period. The ActBlue software does not allow the splitting of the designations by the donor. At the time of the committee's later receipt of the actual check from ActBlue, Committee finance and compliance staff redesignated the contributions to the proper period. However, the notice donation, receipt of the check, and re-designation happened after the 48-hour reporting period had passed, and as such, the contributions were not reported until after the 48-hour reporting period. (2) The Committee's database default settings cause contributions to be designated to the primary election versus the general election. A review of scans and electronic records of the contributions and discussion with both individual and PAC donors revealed that the designation as primary or general for several contributions did not match the expressed donor intent and required correction. Corrections have been made to entries and reporting for the contributors identified in the RFAI, and all contributions reflect the proper period designation and are within FECA contribution limits. Due to these corrections, amendments are being filed for the OCTOBER QUARTERLY REPORT (07/01/2021 - 09/30/2021), YEAR END 2021 (10/01/2021 - 01/31/2022), APRIL QUARTERLY (01/01/2022 - 03/31/2022), PRE-PRIMARY 2022 (04/01/2022 - 04/13/2022), JULY QUARTERLY (04/14/2022 - 06/30/2022), and OCTOBER QUARTERLY (07/01/2022 - 09/30/2022).
