
Dear Sir or Madam:

I today filed a 24 Hour Notice of Disbursements for Electioneering Communications, but a glitch in the system keeps recording item #7 on the filing incorrectly. The online filing is repeatedly recording NO to the question of whether the funds came from a segregated bank account even when I have checked the YES button. After the first submission and reviewing the FEC report, I immediately filed an amendment to correct the report, but it continues to come back wrong.

For the record, I want to be clear that the funds disbursed in this electioneering communication came from a segregated account. I have included in this fax the front page of Form 9 filled out by hand indicating the funds came from a segregated account. Everything else in the original filing is correct as submitted electronically.


