This letter is in response to the problems you identified with National Pork Producers Council Pork PAC FEC filings, per your letter of October 7, 2013.

Corrective Actions

1. Regarding Mark Pryor for U.S. Senate, the following corrections have been made, and will be shown as memo corrections on our 2014 October 15th quarterly report.
 - a. A \$5,000 disbursement reported 5/20/2014 was incorrectly reported as primary-2014. It should have been reported as a \$3,000 disbursement to primary-2014, and a \$2,000 disbursement to general-2014. A copy of the Schedule B pertaining to the corrections is included for your review.

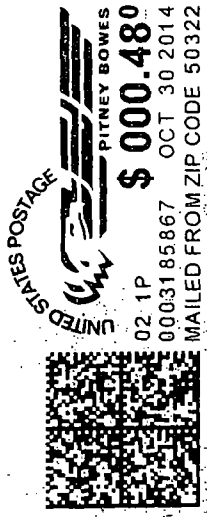

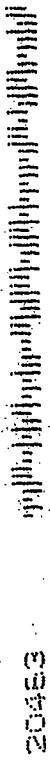
