On February 24, 2003, we submitted to you our response to your letters to Thomas C. Roberts, Treasurer, Van Ness Feldman, P.C. Political Action Committee ("VNF PAC"), dated January 29, 2003. These letters were prompted by the Federal Election Commission's ("FEC") preliminary review of several reports filed in 2002 by VNF PAC, and raised questions concerning certain information included in those reports.


Dear Ms. Kinney:

Van Ness Feldman, P.C. Political Action Committee ("VNF PAC") recently received a letter from the Federal Election Commission prompted by the Commission's preliminary review of the July, 2002 monthly report (covering the period from June, 2002 through June 30, 2002) filed by VNF PAC. The letter questioned the permissibility of a \$500 contribution VNF PAC made to Rehberg for Congress on June 11.

Our review of the issues raised by the Commission's letter indicates that, due to an inadvertent clerical error, VNF PAC's contributions to Rehberg for Congress for the 2002 general election exceed the Commission's contribution limits by \$500. As a result, in accordance with FEC regulations, we respectfully request that you refund \$500 to VNF PAC as soon as possible.
