Dear Mr. Adams:

This letter is prompted by the Commission's review of your debt settlement plan (DSP). In order to complete our review, the following information is needed:

- For a DSP to be considered valid it must be signed by the Committee's treasurer. Please file an amended DSP that is signed by the treasurer.

- On Line 6 of Part I, you list \$140,935.47 as the total amount of debts owed by the Committee. The Commission calculates the total debts listed in Part II and Part III of your DSP to be \$133,202.74. All debts owed by the Committee must be addressed in either Part II or Part III of your DSP. Please file an amended DSP to correct this discrepancy.

- On Line 7 of Part I, you list the total number of creditors owed by the Committee as fifteen (15). The Committee's 2009 November Monthly Report lists nineteen (19) creditors. The Committee has reported debts owed to Brian Anderson, John Livingstone and Elizabeth Livingstone that are not addressed in your DSP. Please file an amended DSP, or an amended 2009 November Monthly Report, to correct this discrepancy.

- On Line 9 of Part I, you list \$70,050.12 as the amount owed to creditors in Part II of the DSP. The Commission calculates the total debts listed in Part II of your DSP to be \$73,792.76. Please file an amended DSP to correct this discrepancy.

- On Line 13 of Part I, you have indicated the Committee does not have sufficient funds to pay the amount entered on Line 10 (Total To Be Paid To Creditors In Part II). Please file an amended DSP to explain where the Committee intends to get the funds (\$17,500.00) required to make the payments indicated in the DSP.

- In Part II of your DSP you have an agreement with the creditor BB&T, to settle a debt owed of \$26,067.54. The Committee's 2009 November Monthly Report lists two debts owed to BB&T, one (1) to "BB&T Bankcard" for \$22,495.00 and another owed to "BB&T" for \$3,700.00, for a combined total of \$26,195.00. Please file an amended DSP that addresses both debts and clarifies the discrepancy.



- In Part II of your DSP you have an agreement with the creditor Huckaby Davis Lisker to settle a debt owed of \$11,821.00. The Committee's 2009 November Monthly Report lists the debt owed to Huckaby Davis Lisker as \$13,128.36. Please file an amended DSP, or an amended 2009 November Monthly Report, to correct this discrepancy.
- In Part II of your DSP, Section A and Section B have been left blank for all agreements. Please file an amended DSP to provide the required information.
- In Part II of your DSP you have failed to identify the type of creditor for "Catterton Printing" and "Omega List Co." Please file an amended DSP to correct this omission.

Unlike previous election cycles, you will not receive an additional notice from the Commission on this matter. If the information is not provided, the processing of the DSP will be discontinued. You are reminded that until the Commission is able to complete its review, all debts including the debts involved in the DSP must be continuously reported. (11 CFR §104.11)
