RE: Amended Mid-Year Report (1/1/93-6/30/93) dated September 19, 1994.

This letter is in response to the above referenced report. Pursuant to your telephone conversation with my staff and review of your letter dated December 22, 1994, I have re-amended the amended 1/1/93-6/30/93 report as follows:

Beginning cash balance

There were deposits in transit equalling \$115.03 that created timing difference between the 12/31/92 year end report ending cash balance and the beginning 1/1/93 cash balance. The amended mid-year report (1/1/93-6/30/93) dated September 19, 1994 has the correct beginning cash balance.

Contributions received that aggregate \$200 or less per individual

This point was noted and will be taken into consideration for future filings.

Schedule H4- Administrative/voter drive event year-to-date

I have properly included the administrative/voter drive event year-to-date amounts on the schedule H4.

Provide amount for each disbursement itemized on schedule H4

I have amended the schedule H4 to support Line 21(a).

Contributions to non-federal committees

I have reviewed the schedule H4 and noted that the disbursements to Friends of Tom Riley and Friends of Harriett Weider were incorrectly listed on the schedule H4. These disbursements should have been listed on schedule B for Line 23 of the detailed summary page. I have amended schedule H4 and have added a page for schedule B.

As a result of the above error, schedule H2 was deleted from our report and schedule H3 was reviewed for its accuracy. Due to the review of schedule H3 and my records, this schedule was amended to properly reflect the actual transfers between the federal and non-federal accounts. There was never an actual transfer to the federal account from the non-federal account for allocated cost related to Friends of Tom Riley and Friends of Harriett Weider; therefore, schedule H3 was amended to change this error. As a result of this change, a transfer of \$400 from the federal account to non-federal account is not necessary.

Other

Pursuant to your discussions with my staff, I have included schedule A, page 3 of 8, which was missing from your report.

Your total of \$4,045 plus \$495 (page 3 of 8, schedule A) will equal \$4,540, which agrees with Line 11(a)(i).

As a result of the above issues, the detailed summary page has been amended.
