Dear Sirs:

I am enclosing for filing an amended report for the 1/1/99 - 6/30/99 reporting period for the ARAMARK Political Action Committee.

The report is being amended to reconcile the reported cash on hand at the close of the reporting period to the actual cash on hand at that time.

We have reviewed the reconciliation differences and their causes with Andrea Wilkins, FEC Analyst, and she concurred with our treatment of the items and recommended that we file this amended report.

The amended report makes two changes to the originally filed report. First, it reflects the payment of an unknown check for \$797.85 that was charged against the PAC's bank account. This unknown check is possibly fraudulent. We are reporting it on Schedule B on line 21B. If we recover the funds, we intend to report the recovered funds on line 15 of FEC Form 3X. Second, the amended report reflects a reduction of \$1,859.54 to the opening cash on hand balance, which amount represents an unreconciled difference. The difference is due at least in part to previous overstatements of deposits reported to the FEC for prior periods due to an error in transmitting payroll withholding data from ARAMARK's payroll system to our FEC reporting software. Also, no thorough reconciliation was done when we installed our FEC reporting software in 1996. There may have been other outstanding unreconciled items at that time. Therefore, the unreconciled difference could also include a prior difference that was carried forward. Ms. Wilkins agreed that an adjustment to the opening cash on hand balance was the appropriate way to report the unreconciled difference so that it will not be carried forward to future reports.


