I have enclosed an amendment to our January 31, 2006, Year-End Report.

The amendment makes the following additions and change:


A. In-kind contributions for Mr. Shawn Wendell and Mr. Edward Zielinski are added on the attached pages 766.1 and 881.1.

B. A contribution was designated in writing (at the time the contribution was made) as a joint contribution. Because of a data entry error, the contribution was attributed entirely to Ms. Margot Knight. An amended page 427 changes the contribution to the desired joint contribution.

C. United Parcel Service has merged with Overnight Corporation. The PACs of both companies had contributed to Jon Kyl for U.S. Senate. To prevent the PACs of the merged companies from exceeding the Primary contribution limits, United Parcel Service PAC requested that \$2,000 of their November 7, 2005, contribution be re-designated for the General Election. This change is reflected on the attached pages 88 and 88.1.

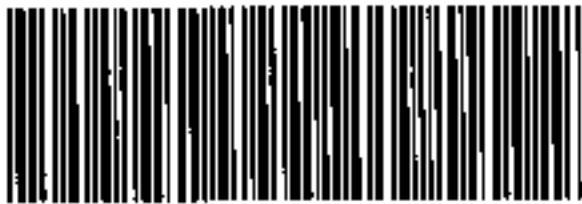
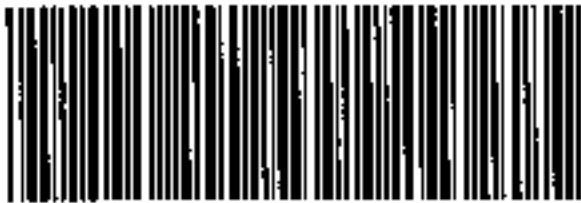
