
-Schedule B supporting Line 23 of your report discloses contributions to "2005 Joint Candidate Committee" and "2006 Joint Candidate Committee"; however, you have also disclosed, as memo entries linked to these disbursements, apparent earmarks to federal candidates (see attached). Please clarify whether the memo entries represent earmarked contributions made by your committee through "2005 Joint Candidate Committee" and "2006 Joint Candidate Committee" to the candidates listed, or if you made the contributions to the political committees exercising no direction or control over how the funds were to be used. If the latter is the case, please do not include the candidates' names on your report. Please amend your report to clarify the ultimate recipient of this contribution(s).

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. **Requests for extensions of time in which to respond will not be considered.** Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.
