As reported in the 2010 Pre-General Election Report, a contribution in the amount of \$5000 was made to the Ben Chandler for Congress committee on October 4, 2010. Very shortly after making the contribution, AFAM PAC officials realized a check in this amount should not have been issued because the PAC does not yet have multicandidate status. AFAM PAC immediately requested a refund from the candidate committee. This refund represents a partial refund of the \$5000 contribution.
