Dear FEC -

The following is a submission to establish "Best Efforts" concerning the letter we received on 18 July 2007 (ID C00113001) that stated the need to provide the Occupation and Employer for our donors of over \$200. We accrued a total of 11 hours attempting to contact the donors in question by both phone and mail.

Unfortunately we received only two responses. In order to prevent this from happening again we have made a permanent change to our donor solicitation card requesting donors provide us with their Occupation and Employer. Please be aware that many of our members are retired. Following is a description of the process we followed in order to establish our Best Efforts:

1. July 25- Emailed National Head Quarters requesting a list of addresses for the donors in question
2. July 26- Received list from National
3. July 26- 3 Hours on the phone with the Information Operator obtaining phone numbers for donors in question
4. July 27- Two people spent 2 hours calling everyone on the list to explain the situation and request the information
5. July 31- One person spent 3 hours calling everyone on the list a second time to attempt to acquire the information
6. August 2- One person spent 3 hours making a third phone call to all donors in question, no success at all
7. August 4- Everyone who was not spoken to personally on the phone was sent a letter explaining the situation
8. August 13- Have received only one response out of all the donors in question, will file best efforts today

As you can see, we have made all reasonable attempts to locate this information in the time allotted. Unfortunately many of our members are retired or deceased, making it difficult for us to contact them. As previously stated, our method of donation collection is in the process of being altered to ensure that this problem does not happen again. Thank you for your understanding.
