Thank you for your letter of July 2, 2008. I have read your letter carefully and reviewed my filings for the Fund for America's Future (C00388934).

When we made the contribution of \$5,000 to Wicker for Senate on March 31, 2008, we believed the Primary Election in Mississippi had not yet occurred. In cases where the Primary has already passed, we would normally redesignate the funds to the General Election. However, by the time your letter informed us of the correct date of the Primary, we were already outside of the 60-day window where we could redesignate the donation. Therefore, we requested, and have since received, a refund of the donation from the Wicker for Senate campaign. Enclosed are copies of our refund request letter and the subsequent refund check.
