Please be advised that contributions to federal candidates should be disclosed with the full name of the candidate committee entered as the payee. Please amend your report accordingly.

-Schedule B supporting Line 29 of your report discloses disbursements to individuals for "Exempt Legal Services" and "Exempt Accounting Services." Please be advised that legal and accounting services received by your committee that are exempt from the definition of contribution should be disclosed as memo entries on Schedule A supporting Line 17 of the Detailed Summary Page. 11 CFR §100.86, 104.3(h), and 114.1(a)(2)(vii) Please amend your report accordingly.


Please note, you will not receive an additional notice from the Commission on

Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. **Requests for extensions of time in which to respond will not be considered.** Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
