Dear Mr. Micheli:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Schedule E of your report lists activity which has been disclosed as an independent expenditure(s). Please be advised that party committees are prohibited from making independent expenditures on behalf of federal candidates. See 11 CFR §110.7.

The disbursement(s) made by your committee may qualify as exempt activity which is not subject to contribution and expenditure limits. For more information, please refer to 11 CFR §§100.7(b)(9), 100.7(b)(15), 100.8(b)(10) and 100.8(b)(16) and your campaign guide. If you find the activity does not qualify under these exemptions, please amend your report by disclosing the activity as in-kind contributions on Schedule B supporting Line 23 of the Detailed Summary Page.

Expenditures made on behalf of federal candidates in connection with the general election may, alternatively, qualify as coordinated expenditures under 2 U.S.C. §441a(d). Please note that a local, district or subordinate committee must first receive authorization from the state central committee in order to expend money under the coordinated expenditure limitation. Such activity must be reported on Schedule F supporting Line 25 of the Detailed Summary Page.

Please clarify this matter and amend your report according to the above guidelines.

-On Schedule H4 supporting Line 21(a) of the Detailed Summary Page, you have failed to include the total EVENT

YEAR-TO-DATE amount for a payment(s) to various vendors. Please amend your report to include the missing EVENT YEAR-TO-DATE total(s).

-Your calculations for Lines 6(c), 24, and 30, Column B appear to be incorrect. FEC calculations disclose these amounts to be \$388,832.90, \$24,025.25, and \$387,080.91 respectively. Please provide the corrected totals on the Summary and Detailed Summary Page.

-Please clarify all expenditures made for advertising on Schedule B. If a portion or all of these expenditures were made on behalf of specifically identified federal candidates, this amount should be disclosed on Schedule B supporting Line 23 and include the amount, name, address and office sought by each candidate. 11 CFR §104.3(b)

-Please clarify all expenditures for "voter registration" and "get-out-the-vote". In addition, if any of the voter registration or get-out-the-vote activities referenced House or Senate candidates, they should be allocated accordingly, unless merely incidental to the overall activity. If a portion or all of these expenditures were made on behalf of federal candidates, they should be reported on Schedule B for Line 23 of the Detailed Summary Page, as appropriate.

-Schedule A of your report (pertinent portion(s) attached) discloses a receipt of \$5,000 from the Republican National State Elections Committee. Please clarify whether this transfer is from an account maintained by the Republican National Committee for non-federal purposes. If so, be advised that such a transfer is prohibited by 11 CFR §102.5(a)(1)(1) and the full amount of the transfer should be returned to the non-federal account. Please inform the Commission of your corrective action immediately in writing and provide a photocopy of your check for the transfer-out. In addition, the transfer-out should be disclosed on Schedule B supporting Line 22 of your next report.

Although the Commission may take further legal action regarding the acceptance of funds from a non-federal account, your prompt transfer-out of the impermissible funds or clarification of the transaction, will be taken into consideration.
