
Dear Ms. Ray:

In response to the enclosed notice received by the above referenced political action fund and as I explained during our telephone conversation last week, my client, District 1199C had an election last year and installed new officers including a new treasurer. Our firm has been engaged to prepare the Fund's FEC and state filings under the new administration, the first being the Mid-Year Report referred to in your notice. Prior to our engagement, the former treasurer prepared and filed all PAC reports through 12/31/2018.

The cash on hand January 1, 2019 of \$5,875.10 is reconciled to the general ledger and to the Fund's depository bank account. We know this amount is accurate. When reviewing the reports filed by the past treasurer, we noticed that the 1/1/2018 and 12/31/2018 cash balances are identical, and that the 12/31/2018 balance does not reconcile with the amount we know to be accurate.

We are in the process of compiling as much information as we can from the previous administration's records in an effort to correct the previous filings. We can assure you that moving forward the reports will be prepared accurately based on the Fund's activity and reconciled to its depository bank account.

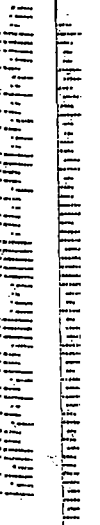

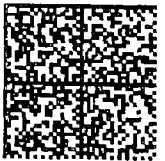
