The following further amends the October 15th, 2012 quarterly filing and overrides the most recent amendment to said filing, dated 10/24/2012. The changes reflect the correction of a computational error in line 21(a)(ii), column B in the amount of \$0.63. The initially listed total was \$2431.14 and has been corrected to \$2431.77. In addition, line 21(c), column B has been amended to reflect this. Total operating expenditures now read \$4052.97 instead of \$4052.34. Although these changes have been made, these errors were isolated in these two lines and thus lines 31, 32 and 8 remain correct.
