This is in response to your letter on the above referenced report.

We have reviewed the above referenced report and an Addendum providing contributor information was included with the initial filing of the report.

Please be advised that the Democratic Senatorial Campaign Committee exercises "best efforts" in attempting to obtain contributor information such as full name, mailing address, occupation and employer. All the committee's solicitations and invitations request the required information. As the money is entered in the database, letters are sent to donors. As information is received, the donor database is updated and addendum reports are sent with our next FEC report. The employer/occupation information included in our FEC reports is provided directly by the contributors.

Based on our review of the referenced report it appears that the contributions received from unincorporated proprietorships and partnerships were attributed to the partners as memo entries on Schedule A.

Please be advised that all payments reported on Schedule A, supporting Line 15, received from federal candidate committee(s) for goods and services provided by this Committee, are at the usual and normal charge for the goods and services provided. With respect to Rent/Occupancy, our Committee charges candidate committee(s) the prevailing commercial rent for comparable rental space.

We have amended Schedule B to clarify the description "Cashiering Direct Mail."

All the expenditures made for Catering/Facilities, Printing, Cons/Prof.Serv, Direct Mail Dev., Telemarketing, Data Entry Direct Mail, Letter Production/Mailing, Data Processing Direct Mail, Fees Direct Mail Processing, Postage/Shipping, Cashiering Direct Mail and Data Modeling Direct Mail as reported on Schedule B, Line 21b, are to support Committee activities, and are not made on behalf of specifically identified federal candidates.

Please be advised that the independent expenditures reported on Schedules E in support of federal candidates: Erskine Bowles, Ken Salazar, Betty Castor, Daniel Mongairdo and Inez Tenebaum were properly classified and reported as independent expenditures as defined under 2USC Section 431(17).

We have amended our 30 Day Post General Report, Schedules E disclosing independent expenditures, to include the signature of the treasurer.

With respect to the discrepancies in the reporting dates for independent expenditures shown in Schedules E, supporting line 24 and the dates of public dissemination included in the 24 hour reports; the Committee reported on Schedules E in the FEC report the actual date of the check to the vendor, not the date of public dissemination. We have amended our FEC report, Schedules E to include the date of public dissemination for payments made to Adelle Netterville dated 10/14/04, Great American Media on 10/14/04, Greer Margolis Mitchell Burns dated 10/14/04, Great American Media dated 10/20/04 and Struble Eichman dated 10/20/04 as included in your attachment.

Regarding missing 24 hour notices, please be advised that there were no missing 24 hour notices, just the inability to reconcile total dollars as reported on Schedules E with the detail dollars reported on the original 24 hour notices. Please see the enclosed Schedule which list the dates of public dissemination for those payments listed in your attachment as "Missing 24 Hour Notices."

Regarding the limitation on making coordinated party expenditures on behalf of federal candidates in Colorado (Ken Salazar) and Florida (Betty Castor) and North Carolina (Erskine Bowles), we provided you with copies of agreements between this Committee and Democratic National Committee; and the respective state Democratic Parties designating this Committee as agent for making expenditures pursuant to 2 U.S.C section 441a (d). Please refer to our letters dated June 28 and June 30, 2005. With respect to Kentucky (Daniel Mongairdo) please find enclosed a copy of the agreement, dated 10/15/04, between this Committee and the Kentucky Democratic Party Carolina Democratic Party designating this Committee as agent for making expenditures pursuant to 2 U.S. C section 441a (d).



Dear Executive Director Jacobs:

This letter sets forth in full the agreement between the Kentucky Democratic Party and the Democratic Senatorial Campaign Committee concerning 441a (d) spending authority on behalf of the Democratic Senate nominee in the 2004 general election for the United States Senate in Kentucky.

441a(d) Spending Authority

1. The State Party hereby designates the DSCC as the agent of the State Party for the exclusive purpose of making expenditures pursuant to 2 U.S.C. § 441a(d) not to exceed \$228,113.00 on behalf of the Democratic nominee in connection with the general election for United States Senate in Kentucky held on November 2, 2004. The DSCC hereby accepts such agency.

2. In exercising its authority pursuant to the Agreement, the DSCC will comply with the limitations and other reporting requirements of the Federal Election Campaign Act, as amended, and the regulations promulgated thereunder.


3. The DSCC will report to the Treasurer and Executive Director of the State Party the cumulative amount expended by the DSCC in connection with the general election under the delegation of authority provided under this Agreement


