Corbin Jones:

This letter is in response to the notice I received from your office regarding the Monterey County Republican Central Committee's Federal 30 Day Post General Report.

The notice was in response to our 30 Day Post General Report (10/19/06-11/27/06), and made note of five issues. The first issue pointed out a discrepancy between ending cash balances of our 12 Day Pre-General Report (10/1/06-10/18/06) report and beginning balances of our 30 Day Post General Report (10/19/06-11/27/06). This discrepancy was caused due to an accounting error, and has since been remedied.

The second issue raised was that of the totals disbursements listed on the Summary Page Line 7(a), 21(a)(i) and 21(a)(ii), 30(b), 30(c) and 32. This was also due to an accounting error, and has since been remedied.


The third issue raised was in response to Schedule B. The expenditures in question did not clearly identify a candidate for Federal office nor did they promote, support, attack or oppose any candidate for Federal office. The activity in question does not meet the definition of Federal Election Activity. All activity is properly reported.

The fourth issue raised was in response to Schedule B. The reimbursements to Mainstream Consulting total \$16,762.90, there is not a discrepancy in this amount.

The fifth issue raised was in response to Schedule H4. The reimbursement to Mainstream Consulting total \$14,938.15 and the original vendors have been properly identified.

I trust this is adequate enough response to the issues raised regarding our reports. In the future, we will attempt to keep these types of errors to a minimum. If you have any inquiries please do not hesitate to contact me. Thank you very much for your attention to this matter.
