Dear Filer:

This letter is prompted by the Commission's preliminary review of the Report of Independent Expenditures Made and Contributions Received (FEC Form 5) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. An adequate response must be received at the Commission by the response date noted above. Additional information is needed for the following 1 item(s):

- Your quarterly report discloses independent expenditures that do not appear on 24- hour reports (see attached).

Commission regulations require that you file 24-hour reports once independent expenditures aggregate \$1,000 or more after the 20th day but more than 24 hours before 12:01 a.m. of the day of the election. The report must be received at the Commission by 11:59 p.m. Eastern Standard/Daylight Time of the day following the date on which the communication was publicly distributed or otherwise disseminated. In the report, you must include information for all independent expenditures that have not been previously reported. Each time you make subsequent independent expenditures relating to the same election that aggregate \$1,000 or more, you must file another 24-hour report disclosing these independent expenditures. (11 CFR § 109.10(d) and (e))

Please clarify the circumstances regarding the untimely disclosure of the independent expenditures in question.

In addition, there appear to be inconsistencies in the amounts reported on 24-hour notices and Year End reports for certain independent expenditures (see attached).

Please clarify the amounts in question in an amendments to these reports or provide an explanation for the difference in amounts.
