Neither the contribution checks nor any accompanying communication from Gridiron PAC designated those contributions to any particular election. Because those contributions were made after the primary election date, they should have been attributed to the general election. In addition, this amended Schedule B inserts data regarding the office sought, state and congressional district for all contributions made.
