This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 2 item(s):

1. Commission Regulations require the continuous reporting of all outstanding loans. This report omits the loan(s) itemized on your previous report(s). Please amend your report(s) to indicate the current status of the following loan(s): 1/3/12 (\$100.00), 1/12/12 (\$1,000.00), 1/27/12 (\$900.00), 2/8/12 (\$10,000.00) and 3/5/12 (\$5,000.00). (11 CFR §§ 104.3(d) and 104.11)
2. The loan payment(s) disclosed on Schedule C does not equal the loan payment(s) itemized on Schedule B. Each loan payment made by the committee must be itemized on Schedule B, regardless of the amount of the payment, and included in the payment to date calculation on Schedule C. Please correct this discrepancy and file an amendment to your report. (11 CFR § 104.3(b)(4)(iii))

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**
