Dear Ms. Parks:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Schedule A of your report (pertinent portion attached) discloses the receipt of a refund of an excessive contribution made to Harvey Gantt for U.S. Senate '96. The Act precludes a political committee, other than a multi-candidate committee, from making a contribution to a candidate for federal office in excess of \$1,000 per election. 2 U.S.C. §441a(a) In addition, it appears that the disbursement of this contribution has not been previously reported by your committee. Please amend the reporting covering the period during which the contribution was made to disclose the disbursement on Schedule B supporting Line 23 of the Detailed Summary Page.

The Commission notes the receipt of the excessive contribution. Although the Commission may take further legal action concerning the excessive contribution, your prompt action in obtaining a refund of the contribution will be taken into consideration.

-For future filings, please note that your committee need only file the pages on which you have itemized activity. Schedules with no activity may be omitted.

-For future reporting purposes, please note that you should provide the appropriate figures for Lines 20 and 31 of the Detailed Summary Page. Since your committee does not report any shared federal/non-federal


activity, all of your receipts and disbursements are considered to be federal. Thus, your total receipts and your total federal receipts (Lines 19 and 20) should be the same, just as your total disbursements and total federal disbursements (Lines 30 and 31) should also be the same.

-It has come to the attention of the Federal Election Commission that the reports you have filed during the current election cycle do not reflect the appropriate coverage dates for quarterly filing status. Please be advised of the filing dates and coverage periods for the 1997-1998 election cycle and fill in the appropriate dates on Line 5 of the Summary Page.
