This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Schedule A of your report discloses the receipt of \$30,000 from your connected organization on October 22, 1993. The purpose of the \$30,000 receipt from your connected organization has been disclosed as a reimbursement of operating expenses/legislative consultants (pertinent portion attached). Under 11 CFR §114.5(b)(3) a separate segregated fund may be reimbursed for any solicitation or other administrative expense provided that the reimbursement is made no later than thirty (30) days after the expense was paid by the separate segregated fund. FEC records indicate, however, that the total administrative payments reported by your committee during the period of 9/22/93 through 10/22/93 equals \$26,531.


Please provide further clarifying information regarding the date that your committee made payments for any solicitation or other administrative expenses. To the extent that the reimbursement was made beyond the thirty (30) days permitted under 11 CFR §114.5(b)(3), the Commission recommends that you refund the full amount to the donor in accordance with 11 CFR §103.3(b).

Please inform the Commission of your corrective action immediately in writing and provide a photocopy of your check for the transfer-out or refund. In addition, any transfers-out or refunds should be disclosed on Schedule B supporting Line 22 or 28 of the report covering the period during which the transaction was made.

Although the Commission may take further legal action concerning the acceptance of prohibited contributions, prompt action by your committee to transfer-out or refund the amount will be taken into consideration.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
