
Dear Analyst:

This letter is a response to your letter of August 21, in which you requested more information and possible corrections from the referenced report. I will follow the sequence of the items in your letter as I provide my responses:

1. Thanks for pointing out our missing 48 Hour Reporting Reports, and we pledge to do better in the upcoming General Election. We have released the individual that previously received the mail for our committee, and found a more reliable person for this task. There will also be more supervision of our mail clerk than before. The referenced report has been amended to include the missing 48 Hour Reports. We realize this retroactive action defeats the purpose of these reports, but at least now the record is complete.
2. Descriptions of campaign disbursements were improved to provide better clarity of purpose, and the referenced report was amended. One description was an inelegant attempt to document payment of debts from the pre-primary period, but this is now replaced with a simpler statement of purpose. There doesn't appear to be any good guidelines for the handling of pre-primary debts within the filing software.
3. We keep a list outside of FECfile to document in-kind contributions, including those of the candidate. Memo entries in the referenced report are the vendors which have reached \$200 in total disbursements during the period. As this is a cumulative list since the Primary Election the number of Memo entries will continue to grow with each successive report.

Please contact us again if you have suggestions for improving our reports. Our business on this side of the campaign is to provide the best reports that we can.

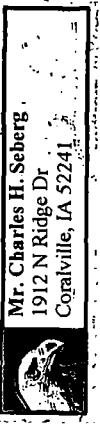

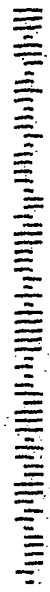
