The following amends the Bulldog Democrats PAC's 12-day Pre-Election filing: 24 submitted on October 24, 2012. The changes reflect the correction a computational error En in the amount of \$0.63 on lines 21(a)(ii) and 23 reported in the most recent amendment to the 2012 October quarterly report. Line 21(a)(ii), column B now reads \$2536.37 instead of \$2535.74 and line 21(c), column B now reads \$4337.45 instead of \$4336.82.

In addition, the amendment corrects transcription errors in column A of line 22 and column B of lines 22, 23 and 24. No transfers were made to affiliated /other party committees during this period, and line 22 columns A and B have been corrected to now read \$0.00 instead of \$808.98. The sum \$808.98 reflects the total amount of contributions to federal candidates/committees and other political committees this period, as supported by the schedule E in the original filing, and line 23 columns A and B have been corrected to both read \$808.98. Lastly, line 24, column B has been corrected from \$0.00 to \$2666.16 to reflect the independent expenditures rand in previous reporting periods.

As before, the errors carried over from the 2012 October quarterly filing were isolated in lines 21(a)(ii) and 21(c), and the total remains unaffected. In addition, transcription errors merely affect the placement of the expenditures and not the total amount disbursed. As a result, the initially listed totals in lines 31, 32 and 8 remain correct at \$7812.59.




