Response to FEC Letter of August 22, 2013 requesting additional information for the March Monthly Report (02/01/2013 - 02/28/2013):

1 - Due to corrections made to Schedule H1 ratio for January Monthly Report, and this February Monthly Report, the totals listed on Lines 21(a)(i), 21(a)(ii) and 32 in the Column B Summary Pages have been corrected.

2 - This referenced Report has been amended with a corrected Schedule H1 to reflect proper fixed percentage for allocated Federal and non-Federal administrative costs. The non-Federal share for this Report has changed from \$68,013.24 to \$63,212.34. However, only \$32,000 was transferred from non-Federal to Federal account for this period.

Response to FEC Letter of January 30, 2014 requesting additional information for the March Monthly Report (02/01/2013 - 02/28/2013)

Increase in receipts totaling \$57,321.74 was due to an entry made on Schedule A Line 12 for an In-Kind transaction involving an equipment transfer to RPV. RNC sent a letter to RPV Chairman which is then normally forwarded to me. However, I did not receive this letter until after the elections when the equipment was scheduled to be returned. Measures have been initiated to prevent this occurrence going forward.
