Refunds from previously disclosed allocable expenses have been allocated between the federal and non-federal account and appear in the August monthly report. Transactions include 2 Oakland Three LLC, Biscayne Plaza II LLC, Palm Springs Mile Associates Ltd, and TECO Energy Inc., AT&T, Hyatt Regency Miami, and Samar Barhoush. The non-federal share of allocated transactions has been transferred to the non-federal account in the amount of \$3467.01. Premium Assignment refund represents allocated transactions and 100% pure federal transactions. The non-federal share of allocated transactions has been transferred to the non federal account in the amount of \$11,887.25. Bright House Networks and Department of Water and Sewers non-federal share of allocated transactions has been transferred to the non-federal account in the amount of \$1212.01. The committee has amended the August monthly report to reflect the original fundraising ratio disclosed on the H2 schedule. The transfers made were based upon the original ratio which has a higher federal share than the adjusted ratio.
