

Thank you for your cooperation and understanding in pointing out this matter and in helping us to resolve it.




Dear Sirs:

The Federal Election Commission has informed our PAC that we have given your campaign an excessive contribution in the amount of \$2,500. It reviewing our records we concur with the Commission's findings. During 2010 we contributed \$5,000 to you in March and another \$5000 in August which contributions equal the limit allowed by law.

However, in October, 2010 we sent you a check for \$2,500. which put our contributions over the legal limit. Therefore, we are formally requesting a refund from your campaign of \$2,500 to correct our error.
