2. THE CONTRIBUTIONS RECEIVED FROM THE ORGANIZATIONS THAT ARE NOT REGISTERED WITH THE COMMISSION DID USE PERMISSIBLE FUNDS TO MAKE THE CONTRIBUTIONS. THE COMMITTEE HAS LETTERS ON FILE FROM ALL THE CONTRIBUTORS IN QUESTION. THE LETTERS DEMONSTRATE THE ORGANIZATIONS RECEIVED SUFFICIENT FUNDS SUBJECT TO THE LIMITATIONS AND PROHIBITIONS IN ORDER TO MAKE THE CONTRIBUTION.

THE PAYMENTS ARE EXEMPT FROM THE DEFINITION OF A CONTRIBUTION OR EXPENDITURE AND DID MEET THE CONDITION THAT NO PUBLIC ADVERTISING WAS USED AND ALL THE FUNDS USED FOR THE ACTIVITY ARE PERMITTED UNDER THE ACT AND THE PAYMENTS FOR THE ACTIVITY WERE NOT MADE FROM TRANSFERS IN FROM THE NATIONAL COMMITTEE TO SPECIFICALLY FUND THE ACTIVITY.
