Dear Mr. Davis:

I am writing in follow-up to my letter dated June 6, 2000 which responded to your letter of May 31, 2000 which had raised several queries regarding the April Monthly Report (for period 3/1/2000-3/31/2000) filed by the Hogan & Hartson Political Action Committee.

My June 6 letter attached for filing an amended April Monthly Report, as well as an amended May Monthly Report. The amended May Monthly Report (period 4/1/2000-4/30/2000) carried through the effect of the amendments made in the April Monthly Report. In addition, as indicated in my June 6 letter, in the course of preparing the amended May Monthly Report, we noticed an inconsistency in the May Monthly Report as originally filed between Line 23 of the Detailed Summary Page (\$10,500) and the sum of the itemized contributions reported on Schedule B which was shown on the report as filed as \$11,500. The correct amount for both lines is \$10,500. The correction to Schedule B to show \$10,500 was made in the amended May Monthly Report which was transmitted to you with my June 6 letter. In looking back at my June 6 letter in the course of preparing our June Monthly Report, I realized that my letter inadvertently describes the amended May Monthly Report as changing the Schedule B number to \$11,500, instead of \$10,500. The amended May Monthly Report as filed is correct, and it is my explanatory letter that is in error. Accordingly, even though the amended report as filed is correct, I wanted to correct the record of my correspondence with you.
