Dear Ms. Winship:

This responds to your letters dated July 9, 2008, concerning the above referenced FEC report.

With respect to amending Schedule F of the June Monthly Report (5/1/07-5/31/07) and Schedule F of the April Monthly Report (3/1/08-3/31/08), to include the names of the Democratic Party's nominees for the Senate, we do not believe it is required to amend the reports since the nominees were not determined until dates after the reports were prepared and filed with the FEC. In the case of the June Monthly Report the Maine Nominee wasn't determined until more than twelve months after the report was filed. In the case of the April Monthly Report, the Kentucky Nominee wasn't determined for almost two months after the report was filed.

Regarding reporting receipts from Indian Tribes included in your letter on the April Monthly Report (3/1/08-3/31/08), please be advised that future contributions will be properly disclosed on Schedule A, supporting Line(s) 11(a)(i) of the Detailed Summary Page.

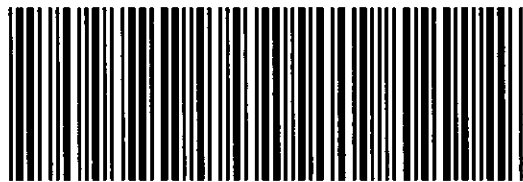
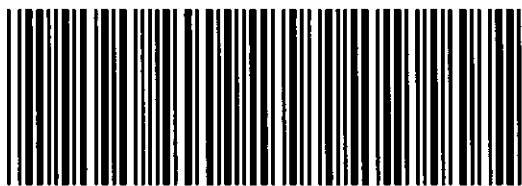
