Capito for West Virginia, FEC id # C00539825, is submitting amended reports covering

Year End (10/1/13 – 12/31/13)
Pre-Primary (4/1/14 – 4/23/14)

April Quarterly (1/1/14 – 3/31/14)
July Quarterly (4/24/14 – 6/30/14)

The Year End, April Quarterly and Pre-Primary amendments are due to the discovery of duplicate datasets by the committee resulting in changes to the aggregated numbers on report lines 11(a)(i) column A, 11(a)(i) Column B, 11(a)(ii) Column A and 11(a)(ii) Column B.

The July Quarterly report is being filed in part because of duplicate datasets affecting the report lines referenced above. In addition to the duplicate datasets the Committee has also discovered an error in reported income that causes an increase in contributions and the ending Cash on Hand.

The increase is due to the Committee's credit card processing company not providing accurate reports of contributions received during the reporting period. The error was discovered by the Committee after the filing deadline when reconciling credit card deposits with reported credit card contributions. While the contributions are technically "received" by the Committee on the date they are processed, the funds are not placed in the Committee's bank until a later date. In this situation the funds were placed in the account in July, when the error was discovered.

New procedures have been put in place with the credit card processing company designed to avoid this issue in the future.

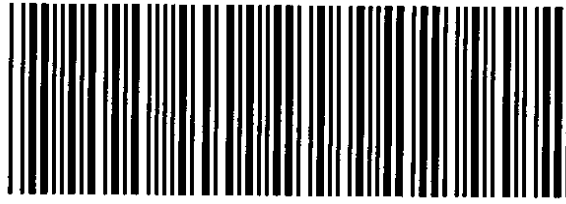

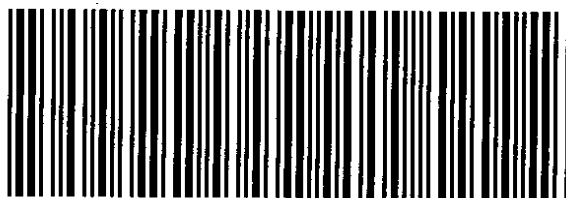
