This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-The Summary Page discloses \$10,825,331.49 on Line 6(c), Column B, but the Detailed Summary Page shows the Line 19, Column B total to be \$10,826,831.49. These figures should be the same. Please amend your report accordingly.

-The Summary Page discloses \$11,669,879.96 on Line 7, Column B, but the Detailed Summary Page shows the Line 30, Column B total to be \$11,671,379.96. These figures should be the same. Please amend your report accordingly.


-Schedule D for Line 9 of the Summary Page discloses \$22,931.23 in payments this period which have not been disclosed on Schedule A for Line 15 of the Detailed Summary Page. Please disclose these receipts on Schedule A and the Detailed Summary Page.

-Please clarify your use of Schedule F to disclose \$22,931.23 in memo entries.
