Dear Sir or Madam:

This letter is in response to the Federal Election Commission's Request for Additional Information dated September 19, 2013. The Commission requested information on two items. After a review of our records, the HSLDA Federal PAC is amending its April Quarterly Report 2013 (01/01/2013 – 03/31/2013).

In specific answer to the Commission's Request, we answer as follows:

1. In the original April Quarterly Report, Schedule B supporting Line 23 contributions showed that several contributions to a candidate for the 2012 General Election were disbursed after the election date. Those contributions were incorrectly dated. All of the HSLDA Federal PAC's in-kind contributions took place in the days immediately preceding the Election, but the bills were paid for after the General Election.

In the amended April Quarterly Report, the contributions have been revised to reflect when the contribution was made to the candidate, rather than when the check was written from our PAC treasury funds. Steps have been taken to ensure proper reporting on future reports.

2. In the original April Quarterly Report, Schedule B supporting Line 23 contributions showed contributions totaling \$3,385.50 that appeared to be earmarked, with no corresponding entries on Schedule A. Those

contributions were not earmarked; HSLDA PAC does not accept earmarked contributions. Instead, the contributions were in-kind, but due to a change in filing software, the memo notation identifying them as in-kind contributions was missing.

In the amended April Quarterly Report, the contributions have been updated to correctly identify them as "in-kind" rather than "earmarked" contributions.

We hope that this explanation and the amended reports will satisfy the Commission's Request For Additional Information in regards to the April Quarterly Report.

Due to a difficulty in electronic filing the Amended April Quarterly Report, I am enclosing a paper copy of the amended report that I will be filing as soon as I receive the correct backdoor password from our Analyst.


