Dear Mr. Angle:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Line 21(a)(i) of the Detailed Summary Page of your report discloses a total of \$369,137 in the federal share of shared federal/non-federal activity. The sum of the entries itemized on Schedule H4, however, indicates the total to be \$363,691. Please amend your report to clarify the discrepancy.

-Line 21(a)(ii) of the Detailed Summary Page of your report discloses a total of \$212,504 in the non-federal share of shared federal/non-federal activity. The sum of the entries itemized on Schedule H4, however, indicates the total to be \$208,874. Please amend your report to clarify the discrepancy.

-Schedule D discloses \$9,076 in payment(s) this period to Lodge at Pebble Beach; however, there are \$250 in payments reflected on your disbursement schedules. Please amend your report to clarify this discrepancy.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days
