This letter is prompted by the Commission's preliminary review of the report(s) referenced above. Please be advised, a memo entry is used to disclose additional information about an itemized transaction and the amount of a memo entry is not included in the total receipts or disbursements for the report.

The Commission notes the purpose(s) provided, "Payment of Credit Card expenses (reported)" and "automated transfer from Bank to PayPal account." Please amend your report to provide clarifying information regarding this activity. (11 C.F.R. ? 104.3(a) and (b))

2. Your report disclosed a category of financial activity that has been reflected on the wrong line of the Detailed Summary Page. Independent Expenditures should be properly disclosed on a separate Schedule E, supporting Line 24 of the Detailed Summary Page. Please refer to the instructions for each line when determining the proper categorization(s) for your next filing. (2 U.S.C § 434(b) and FORM 3X Instructions)

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee

will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**
