

The following amends the Bulldog Democrats PAC's 30-day Post-Election filing and addresses the computational error in column B of line 21(a)(ii) in the amount of \$0.63 made in the 2012 October quarterly filing. This error has been corrected in the most recent amendment to the 2012 October quarterly filing. Line 21(a)(ii) column B now reads \$2549.35 instead of \$2548.72. Line 21(c) incorporates both this correction and a further computational error, and now reads \$6709.32 instead of \$2656.35. The nature of these changes are isolated to their own lines, and the totals in lines 31, 32 and 8 remain at their correct values of \$14,067.44 and \$2686.95, respectively.

In addition, a computational error in line 32 column B has been identified and corrected. It now reads \$11,518.09 instead of \$11,506.13

The most recent amendment to the 12-day pre-general election filing (correcting a transcription error) should address any discrepancies that the commission has found in lines 21(c), 22, 23, 24, 31, 32 and 8 of this filing, and thus, no changes have been made other than those listed above.
