

Dear Mr. Gibson:

We received your letter dated October 17, 2002 in response to our incorrect reporting of contributions to the Tim Johnson for South Dakota campaign committee. We have had subsequent conversations with Chris Morris on this issue and believe we have clarified the situation in our amended reports.

On June 13, 2000 we made a contribution in the amount of \$1000.00 for the Senator's Primary Election. Due to a clerical error, our June 2000 FEC report reflected it as a contribution for the General Election. This should have been recorded as a contribution for the Primary. Our records indicate that we amended this return electronically on August 12, 2002 to reflect the proper designation. Since I do not have the confirmation of receipt from the FEC, this amended return may not have been received. We are submitting another amended return (hard copy) with this letter in hopes that this one will go through.

By including a copy of the page reflecting the correction with this letter, I believe this will serve as an amended report and resolve the open issue related to total contributions to this candidate. However, if there are any other questions, please feel free to contact me at (847) 832-7582.
