This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 2 item(s):

1. Your Committee has checked boxes and/or completed information for Lines 5(e) and 5(h) of your Statement of Organization. Please be advised that you should only fill out information for one (1) box on Line 5. Please amend your Statement of Organization to clarify this apparent discrepancy.
2. Line 6 of your Statement of Organization discloses "CACN - Christian Angel Capital Network, Inc. c/o SmallBizAdvocates.org (Super PAC)" as your Leadership PAC sponsor. However, according to Line 5, your committee is not a leadership PAC. Please be advised a Leadership PAC is a political committee that is directly or indirectly established, financed, maintained, or controlled by a federal candidate or officeholder which is neither an authorized committee nor affiliated with the candidate's authorized committee. 2 U.S.C. §434(i)(8) (B) Please amend your Statement of Organization to address the apparent discrepancy and disclose the appropriate relationship on Line 6.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**
