To Whom It May Concern:

Enclosed is an amended NCRA PAC FEC Form 3X: *Report of Receipts and Disbursements* for the April 15 (2004) Quarterly Report (Q1).

The reason for the amendment is that a \$25.00 contribution made to NCRA PAC was erroneously directed to the accounts of the National Court Reporters Foundation prior to the close of the 2004 first quarter filing. This left the National Court Reporters Foundation owing NCRA PAC \$25.00 and this debt was not appropriately identified in the NCRA PAC 2004 Q1 FEC filing. In the effort to correctly account for NCRA PAC's assets for the 2004 first quarter, a Schedule D should have been included in the original filing.

The amendments to the NCRA PAC 2004 Q1 FEC filing include:

- 1) The addition of \$25.00 to section (9) on page 2, Summary Page of Receipts and Disbursements; and
- 2) The addition of a *Schedule D: Debts and Obligations (Excluding Loans)* in which the \$25.00 debt to NCRA PAC from the National Court Reporters Foundation is properly noted.
