This FEC Form 99 is filed by Bernie 2016 (FEC ID No. C00577130) (the ?Committee?) in response to your Request for Additional Information dated October 19,2016, regarding the Committee?s M8 FEC Report (07/01/2016 ? 07/31/2016) (the ?Report?).

Item 1. The refunds received were issued from the escrow accounts of vendors paid by the Committee. The Committee has amended the M8 report to reflect the relationships for these offsets.

DanJack Enterprises is the COBRA disbursement agent of Blue Cross Blue Shield Maxwel, James S. Jr. ? The offset was inadvertently attributed to Mr. Maxwell instead of the joint account holder, Virginia Caputo. The offset now reports correctly on this amended report. South Dakota Democratic Party ? This contribution was re-classed to correctly disclose as a monetary contribution to the Committee.

Item 2. The debt to Damage Recovery was correctly listed as Debt to Enterprise Rent A Car on the Committee?s M7 Report. The debt payment listed on the Committee?s M7 report now reflects correctly on the report.

Item 3. Please see the Committee?s responses below.

1. Brenda Schouten Beckett ? The donor?s disclosed contributions totaled \$497.91. This total was subsequently refunded on 7/30/16
2. Frank Bernstein- The donor?s disclosed contributions totaled \$229.50. This total was subsequently refunded on 5/19/16 and 6/1/16.
3. Joe Carangi - The donor?s disclosed contributions totaled \$3828.13. The excessive portion, \$1128.13, was refunded on 7/5/16. The refund disclosed on the Committee?s M6 report was voided and reflected on the Committee?s M7 report.
4. Doug Cook - The donor?s disclosed contributions totaled \$350.00. This total was subsequently refunded on 7/30/30/16.
5. Arthur Giangrande - The donor?s disclosed contributions totaled \$3368.92. The excessive portion was subsequently refunded on 5/1/16/15, and 7/15/16. The refund disclosed on the Committee?s M6 report was voided and reflected on the Committee?s M7 report.
6. Bryna Hellman ? The donor?s disclosed contributions totaled \$879.50. This total was subsequently refunded on 1/31/16, 3/31/16, and 7/30/16.
7. David Mindich - The receipt was inadvertently coded as a contribution instead of offset from David Mindich/Wheeler Property Management. The Committee has correctly coded the receipt, received and voided the refund issued. This amended report reflects the correct offset received.
