Dear Ms. Holder:

This is in response to your letter of February 10, 1995, to Paul Magliocchetti Associates, Inc. Political Action Committee (PMA PAC), ID #C00280321. Your letter indicated that a contribution reported on the October 1994 monthly report (9/1/94-9/30/94) may be in excess of the \$1,000 per election limit for a non-multicandidate committee.

After reviewing our records, we concluded that we did inadvertently exceed the limit for contributions to the Darden for Congress Committee. In a subsequent telephone discussion between Kaylene H. Green, Assistant Treasurer for the PMA PAC, and yourself, you suggested it might be possible to redesignate the contribution. Since Darden for Congress is an active committee receiving contributions toward the 1996 House election, we have notified the committee that the contribution originally made on September 14, 1994, will be redesignated to be applied toward the 1996 Primary. Also attached is a copy of our letter to Darden for Congress confirming that intent.

The PMA PAC has been filing monthly reports. However, in accordance with 11 CFR 104.5(c), we plan to file semi-annual reports during 1995, a non-election year. Therefore, the above redesignation will be included in the report to be filed by July 31, 1995, which will also include all other activity of the PAC from January 1 to June 30, 1995.

Thank you for your assistance in resolving this matter. I hope that this action will serve to correct our inadvertent error in exceeding the contribution limits for our committee.

Dear Mr. Darden:

The Paul Magliocchetti Associates, Inc., PAC (PMA PAC) received notification from the Federal Election Commission (FEC) on February 10, 1995, that we may have exceeded the contribution limit to your campaign in 1994.

Upon examination of our records, we confirmed that our contribution of \$500 to your campaign on September 14, 1994, did exceed the \$1,000 per election limit that our PAC is subject to, because the PMAPAC is not a multicandidate committee. We had made previous contributions to your campaign of \$500 on August 17, 1993 (designated for Primary) and \$1,000 on May 10, 1994, (designated General).

After discussions with officials at the FEC, we were informed that you have an active campaign committee which is receiving contributions toward the 1996 election. Therefore, we are redesignating the \$500 contribution made on September 14, 1994, as a contribution toward your 1996 primary election. A copy of this letter is being provided to the FEC to confirm our action. We will be reporting this redesignation on our next report to the FEC, which will be due on July 31, 1995.

We would appreciate your taking action to reflect this redesignation in your records. If you have any questions, please do not hesitate to call us.
