Dear Mr. Krebs:

As the Treasurer of the Pakistani American Physicians Public Affairs Committee ("PAK PAC"), I am transmitting to you the enclosed amendments to all the reports which the PAC filed with the Federal Election Commission (the "Commission") for the calendar years of 1999, 2000 and 2001 to address recent letters from the Commission. Unfortunately, I did not receive these letters until late January 2002 because they were sent to an office which was closed while the tenant was on an extended trip to Pakistan.

Before the Commission letters even issued, I had already directed a review, by an experienced Commission-trained accountant, of all available PAC records, including bank statements, for 1999 forward. This task was time consuming and complicated by three facts: 1) the PAC's previous Treasurer lived in Connecticut where he kept the PAC records; 2) the PAC maintained its bank account in Texas; and 3) the PAC reports appeared not to be reconciled with the bank statements. Not only did I arrange for the audit, but I also saw to it that the PAC account was transferred to a local bank and that FEC reports were prepared based on reconciliations with the bank statements.

The audit ensued to fulfill a conciliation agreement commitment, worked out with Erica McMahon of the Office of General Counsel and the Commission, that the PAC amend all of its reports filed in 1999 and 2000. To accomplish this amendment task, PAK PAC consumed substantial resources in reconciling bank statements with other available records to correct errors in the reports, including the cash on hand figures previously reported. To reflect the correct cash on hand in the

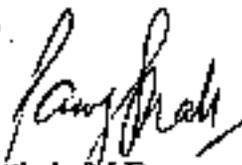

attached amendments, the PAC's federal operating expenditures figure on line 21(b) of the 1998 Year End Report was adjusted for unknown, unidentifiable accounting errors in previously filed reports, and carried forward with the correct cash on hand figures in the amendments to the Summary and Detailed Summary pages of the 1999, 2000 and 2001 reports (attached). The amendments also correct the computation errors mentioned in your letters and list the administrative expenses associated with this non-connected PAC.

These amendments were discussed previously with Ed Ryan and Scott Walker of the Reports Analysis Division, and with Erica McMahon of the General Counsel's Office. Ms. McMahon said she had no problem with our approach as long as PAK PAC complied with the conciliation agreement directive to file amendments for 1999-2000 to reflect the PAC's correct cash on hand balance (which the PAC has done); otherwise she said she would defer to the advice of the Reports Analyst Division as to how to proceed with the amendments. Reports Analyst Scott Walker advised that adjustments on line 21(b) would be a simpler way to address the problem of an incorrect cash on hand figure rather than to waste everyone's time and resources pursuing fruitless additional audits and then try to terminate the PAC in order to start fresh with a new committee.

I hope that these amendments will satisfactorily address the issues in your letters. If you should have any questions, please contact me at 301-490-0500 and I will endeavor to respond as quickly as possible.
