Dear Mr. Rodriguez:

This letter constitutes formal written notification that the Ciro D. Rodriguez for Congress committee is filing reports of receipts and disbursements (FEC FORM 3) that appear to be for the 2000 election.

A review of these reports indicates that your principal campaign committee has no debts from the previous election cycle, and has accepted contributions and/or made expenditures in support of your 2000 candidacy in excess of \$5,000, thus meeting the definition of "candidate" per Federal Election Campaign Laws.
