**Re: Response to January 11, 2017 RFAI - Rebuilding America Now (ID C00618876)**

Ms. Seufert,

This letter is in response to the Request for Additional Information (RFAI) dated January 11, 2017 with respect to the October Quarterly Report filed on behalf of the aforementioned committee and covering the period from 07/01/2016 to 09/30/2016.

1. The RFAI indicated that in Schedule E supporting Line 24 of the October Quarterly Report, certain negative entries were reported impacting expenditures made during this or previous reporting periods. The October Quarterly Report will be reviewed and amended to properly reflect the receipt of offsets to operating expenditures on Schedule A supporting Line 15 of the Detailed Summary Page to clarify for the public record the total amount of receipts and accurately disclose the cash-on-hand amounts.

2. The RFAI indicated that Schedule E of the October Quarterly Report reflects that one or more of the required 48-hour reports may not have been properly filed and fully itemized on Schedule E or reflected as memo entries on Schedule E and reflected on Schedule D as may be applicable. The Committee is aware of the inadvertent omission in the filing of one or more required 48-hour reports during the period, and filed a sua sponte disclosure letter to the FEC, which the FEC acknowledged on October 19, 2019 (re: P-MUR 599). The October Quarterly Report and subsequent reports will be reviewed and amended to ensure that disbursements in the required 48-hour reports, which were voluntarily filed as soon as the inadvertent filing omissions were identified, have been properly reported and fully itemized to clarify for the public record the total amount of independent expenditures and to accurately disclose the Committee's cash-on-hand amounts.

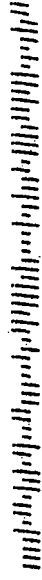
